Rules and Regulations

It's the 3rd Annual Lil' Miss Meeker Pageant! The Pageant will be held Saturday, June 19, 2010 from 1:00-3:00 pm on the Community Stage located in Pioneer Park in downtown Puyallup during the Meeker Days Festival.

Requirements for Participation:

- Contestants must be between the ages of 6 and 9 years old on or before the date of the pageant. Past contestants and runner-ups are eligible to apply. Past winners are excluded from participation.
- The contestant must reside in OR go to school in Puyallup, Sumner, Bonney Lake or Orting.
- All contestants must submit:
 - a Pageant Application signed by parent or legal guardian
 - \$10 non-refundable application fee
 - A photo of contestant
 - Proof of residency (i.e. parent's drivers license or utility billing statement with home address)
- Contestants are required to attend the rehearsal scheduled for Sunday, June 13, 2010 at 1:30 p.m. at Pioneer Park. Dress is casual. There will be a pizza party for all participants after rehearsal.
- Contestants are required to be at the Community Stage Pageant Check-in table by 12:30 pm on Saturday, June 19 in order to be eligible to compete. Any contestant that does not check-in by 12:30 pm will not be allowed to participate.
- One winner will be chosen as Lil' Miss Meeker Days with one runner up. If at anytime Lil' Miss Meeker Days cannot fulfill her duties, the runner up will take her place.
- The winner of Lil' Miss Meeker will be required to make special appearances at the following PMSA/Downtown Puyallup events: Trick-or-Treat Downtown, Santa Parade, Daffodil Parade, and opening day of Farmers' Market 2011. Lil' Miss Meeker will also be required to attend the 2011 Lil' Miss Meeker Pageant to hand over her crown to the 2011 winner. Winner is to provide own transportation to and from each scheduled event.
- A crown and sash will be presented to the winner of Lil' Miss Meeker Days Pageant which is to be turned over to Pageant officials shortly after the pageant. This crown and sash will be stored at the Puyallup Main Street office until needed for special appearances. A smaller version of the crown and the rosette from the sash with the date stitched on it will be presented to the winner to keep. The runner up will receive a ribbon and special certificate.

Judging:

- A panel of judges will be selected by the Puyallup Meeker Days Festival Manager.
- Up to 15 contestants can participate in the event. In the event that more than 15 applications are received, there will be a selection process based on answers to the Contestant Survey. Contestants will be notified of their selection by May 28, 2010.
- Scoring will be based on creativity, personality, and general appearance.
- Each participant will be asked a random question from the judges which will be scored on honesty, creativity and poise.
- Every contestant will wear the official Lil' Miss Meeker Days t-shirt with bottoms and accessories of their choice except for the talent portion of the event. The shirt may be adorned with beads, glitter and paint but can not be cut or torn in any way. Points will be deducted from any candidate that does so. Participants may wear shorts, capris, pants, skirts, etc., and may accessorize with hats, belts, jewelry etc. All bottoms should be at least finger tip length. Points will be given for creativity and originality in accessorizing and decorating their shirt. Excessive makeup will not be allowed and shoes (no flipflops) are required.
- A creative segment will be required. Creative section should be no longer than two (2) minutes in length. Participants should wear appropriate attire for the creative portion of the pageant and provide all props.

Prizes:

- Lil' Miss Meeker will receive a \$100 savings bond.
- First Runner-Up will receive a \$50 savings bond.
- All participants will receive a special Meeker Days t-shirt and certificate of participation.
